To Whom It May Concern,

We are writing to inform you that American Nursery Services, Inc. (hereinafter "Company") will cease all operations effective December 31, 2023. As required by the Worker Adjustment and Retraining Notification Act of 1988 (29 U.S.C. §§ 2101-2109; 20 C.F.R. §§ 639.1-639.10), this letter shall serve as the 60-days' advance notice of the Company's closing, though greater notice is being provided here. This closing will affect all employees of the Company.


As the Company operates largely on a seasonal basis, earlier reductions in the workforce will occur in advance of the Company's final date of operations.
