Dear Ms. Kolvig:

This letter is to inform you that as a result of the unforeseen business circumstances resulting from the sudden and dramatic effects of the coronavirus outbreak and the declaration of a national emergency on our business and our client's operations, Schlumberger Technology Corporation will conduct layoffs at its operations located on the Alaska North Slope. This action is anticipated to be permanent.

Employee separations in connection with this action is expected to start April 22, 2020 and continue through June 2020. Employee termination are expected to be permanent. The affected employees are not represented by a Union. There are no bumping rights for employees related to this action

We apologize that we were unable to provide to you more advance notice of this action. The speed and vast reach of the coronavirus outbreak, as well as the declaration of a national emergency, and national directives for individuals to avoid congregating, limit travel and to work remotely was unforeseeable and caused, and will continue to cause, among other things, a drastic impact on our business. After reviewing our staffing and business needs, we are providing this notice to you at the earliest possible time.
